## Connecting landholders with help

Drought has a major impact on farms, farming families and communities. It is important for landholders to connect with services and support agencies that can help them manage their property, livestock and most importantly their own health and wellbeing and financials during tough times. Good management and planning can help reduce the impact of drought.

**Drought support has changed in NSW.** Landholders are encouraged to visit the DPI Droughthub (<https://www.dpi.nsw.gov.au/climate-and-emergencies/droughthub>) for information on the services and support available during drought conditions. The key message is please don't self assess. Here is a list of local contacts that can help you and your family:

### NSW Emergency Drought Relief Package

The NSW Government has announced a \$500 million Emergency Drought Relief Package to help farmers manage the effects of the current drought.

The three major elements of the \$500 million Emergency Drought Relief Package are:

- \* \$190 million for Drought Transport Subsidies;
- \* \$100 million to cut the cost of farming by waiving fees and charges; and,
- \* \$150 million to bolster the Farm Innovation Fund (FIF) infrastructure program.

The package also includes funding for:

- \* Counselling and mental health;
- \* Critical services in regional communities including transporting water and drought related road upgrades and repairs; and,
- \* Animal welfare and stock disposal.

### Drought Transport Subsidies

The NSW Government will offer a transport subsidy of up to \$20,000 per eligible farm business.

The transport subsidy of \$20,000 per eligible farm business per year equates up to \$30,000 over 18 months from 1 January 2018 to 30 June 2019.

The subsidy is back-dated so farmers can apply it for freight expenses incurred since 1 January 2018.

It covers 50% of the full cost of freight up to a maximum of \$5 per kilometre and 1,500 kilometres per journey.

The subsidy can be applied for the cost of transporting fodder, water to a property for stock, stock to and from agistment, and stock to sale or slaughter.

The subsidy will be back-dated so farmers can access subsidies for freight expenses incurred since 1 January 2018.

Eligibility basics:

- › a farmer who spends a major part of your time and capital working on the farm, or the partner of a farmer who does
- › is not over the income and assets test limits
- › meets mutual obligation requirements
