TENDER PROCESS FOR ANNUAL GRAZING PERMITS

Central West Local Land Service invites applications for Annual Grazing Permits on selected Travelling Stock Reserves under its control, for the period 1 July 2020 to 30 June 2021.

The enclosed information package includes the approximate size and stock waterfacilities available for each reserve. The reserves are located in Coonabarabran, Coonamble, Dubbo, Forbes and Nyngan areas within the Central West Local Land Service.

An application form is also included – please note: there is strictly ONE RESERVE per application. If you are applying for more than one reserve, you will need to obtain another application form. Multiple listings on one form cannot be processed.

Central West Local Land Services recommends that you contact your local office with enquiries in regards to the Reserve you intend on applying for, prior to submitting a tender. All persons applying are to ensure they are fully conversant with the Permit Conditions and eligibility criteria.

Please note:

- It is a requirement to hold and maintain \$20,000,000 Public Liability Insurance for the duration of the Permit.
- A minimum tender price of \$100 per reserve has been set

CONDITIONS OF ANNUAL GRAZING PERMITS

1. The Permit Holder shall not at any time, graze on the said land more sheep or the equivalent in large stock and sheep (and for this purpose one head of large stock shall be deemed to be equal to ten sheep) than allowed by the Authority or Ranger.

If it is considered by the Authority that the land is being overgrazed the Permit Holder may be asked to de-stock the reserve for a period specified by the Ranger.

No hand feeding is to be undertaken on the reserves.

- 2. The Permit Holder shall not, without the previous consent in writing of the Authority assign, encumber, sublet, or sub-grant the permit hereby granted, or any part thereof or graze upon the said land any stock not the property of the Permit Holder (other than bona-fide travelling stock or stock being bona-fide in use by Drovers, Teamsters, Carriers and Travellers). The depasturing of any such stock shall be prima-facie evidence of sub-granting the permit to graze.
- 3. Staff Local Land Services and all persons authorised may enter upon the said land at all times.
- 4. The Permit Holder hereby granted shall not confer upon the Applicant any estate or interest or rights into or over the said land other than the right to graze. Travelling stock and stock bona-fide in use by Drovers, Teamsters, Carriers and Travellers may, with notice to the Authority, at all times enter and graze over the said land.
- 5. No part of the subject land shall be fenced or enclosed in any way or infrastructure installed without the permission of the Authority having been first obtained in writing. Existing fences to be kept maintained by the Permit Holder to an acceptable standard.
- 6. The Authority may issue a permit to any person to place beehives on the said land and the Permit Holder shall not interfere with such beehives.
- 7. It is an offence to walk or graze diseased stock on a public road or Travelling Stock Route or Reserve eg. Animals with lice, footrot, Ovine Johne's Disease, etc.
- 8. Special conditions:
 - (a) All pest animals and weeds on the area to be suppressed and destroyed by the Permit Holder.
 - (b) The Permit Holder shall post in a conspicuous place, a Notice Board indicating for public information the purpose of such Reserve, with the name of the Permit Holder and area of Reserve.
 - (c) During a drought or prior to an impending drought the Authority may, with two (2) weeks' notice to the Permit Holder, temporarily cancel the permit until the Authority is satisfied that seasonal and pastoral conditions have improved.
 - (d) Any fallen or standing dead timber shall not be burned unless otherwise approved by the Ranger, as this can provide habitat for birds and native animals.
 - (e) Stock utilising reserves on the Trangie/ Dandaloo Rd and Nevertire/Tabratong Rd need to be vaccinated for Anthrax at least 28 days prior to accessing the TSR.
 - (f) Any other special conditions as approved by the Authority

- 9. In the event that Special Condition 8(a) is not complied with to the satisfaction of the Authority's Ranger, then the Permit Holder agrees that the Authority may, after giving the Permit Holder seven (7) day's notice of its intention to do so, by its employees or by contractors, enter the land and do all work necessary to comply with that condition.
- 10. The Permit Holder agrees to pay the Authority the expenses of carrying out the work specified in Clause 9.
- 11. In the event of any of the conditions herein before expressed not being in all respects observed and performed by the Permit Holder, the Authority may immediately cancel this permit by notice posted to the Permit Holder's address last known to the Authority or exhibited on the said land and on such cancellation the Permit Holder shall remove from the said land all stock brought by or for them thereon, and no part of the rental paid in advance shall be recoverable by them.
- 12. Through written advice the Minister, or delegate, may at any time for any reason cancel or withdraw this AGP prior to the current expiration date of the permit. A minimum of thirty (30) day's notice will be provided to the AGP holder.
- 13. Subject to any rights you may have under the Act, you are not entitled to any compensation, costs or damages on suspension or termination of this Agreement.
- 14. The Permit Holder must be able to demonstrate that they have adequate land under their control to transfer stock to in the case that Local Land Services instructs the reserve to be destocked or the permit is cancelled for any reason.
- 15. The Permit Holder agrees to pay to the Authority the approved permit fee.
