HLLS Aboriginal Program 20-21

HLLS provided an overview of the on-ground activities and cultural burn activities and showed the planned 2021 schedule for cultural burn demonstration activities in the Hunter. This schedule was



developed by Victor Stephenson. Burns that were delayed from last season are included in this year's schedule

Deb Swan is the Director of Firesticks Alliance – and is declaring it as a conflict

The Board is committed to support the cultural burn program and facilitate it in such a way that it is profitable and productive, this will provide Long-term employment opportunities

New Action – Deb speak to State training services – provide funds for a short workshop or training course around business development

Aboriginal people that want to undertake a cultural burn – can contact the LALC as per HLLS resource document.

The main issue is that we don't know these people who are doing these cultural burns and what their background or qualification is. Need to ensure that Cultural burns are accredited providers

New Action - generate a list of providers for cultural burning- HLLS investigate

LALCs -purchasing more vehicles and fire trucks. This will make the LALCs self-sufficient and won't need a third party like the RFS in the future

Utilisation of existing vehicles and or purchasing of fire vehicles will assist in managing future burns

New Action - Record/audit of all compliant fire fighting vehicles and staff that are available in the Region – HLLS to investigate

New Action – Partnership Action - HLLS organise Hunter regional RFS/Forestry/NPWS representative - to attend at the next meeting

Ashley -declared Conflict of interest – Husband provided the Fire Vehicle for the Biraban burn

Action – Toby to invite Graham Kelly to attend one of the ACAG meetings

Item 6

Overview of the State-wide Aboriginal Community Engagement Strategy

Outcome 1 in the Strategy was broad and unachievable statement – need to adapt to ensure the engagement strategy is captured on a regional level.

Action - HLLS will develop a draft a Regional Aboriginal Community Engagement Strategy and circulate to the ACAG for initial comment.

HLLS to organise a specific workshop which will include an ACAG working group and external facilitator.



Program Hierarchy

There was a group discussion on the Program Hierarchy, it was agreed that everyone would review and provide comments by the end of March 2021. It was noted to include as an Agenda item at every meeting.

Item 10 - Hunter Valley Flood Mitigation Scheme Aboriginal Cultural Heritage Presentation Andrew McIntyre, DPIE

Action- Circulate the DPIE Aboriginal Outcomes strategy

The strategy is ultimately to partner with communities,

New information and data collated around Aboriginal artefacts and places goes to DPIE. The information and data are owned by DPIE. This goes to the AHIMS and has not yet gone back to the communities.

Open to collaborative projects. Work with Community can share knowledge supporting the information that DPIE has collected from the maintenance scheme

Can share that information back into the community, that may be lost into the future a great way to capture that knowledge.

ACAG - would like to see more consultation with the Aboriginal community not just the land councils.

Question to Andrew – ACAG would like to know how many more of these sites are within the river system

HVFMS has surveyed the river – above Maitland - Wallis Creek, Paterson and above Tocal - Williams River.

DPIE need a more comprehensive weed strategy as well as and a cultural heritage management plan.

ACAG - Suggested that there could be opportunity to train LALCs in GIS

Action – HLLS or DPIE to provide a link to the HVFMS website

ACAG – Ensure there is engagement with Aboriginal community and opportunity for Aboriginal procurement.

Action – HLLS to investigate opportunities to run courses on tenders - Aboriginal Training Services NSW – could partner to run training



There is currently funding for on-ground works worth 1.6m over 4 years which will finish in 2022,

The HART team is made up of a team of 4 - HART have a training, work component and can also do work on Aboriginal cultural issues

Upcoming projects include Wollombi brook/Congewai Ck, Wollemi

Next steps - will involve community engagement, which has been limited

Action - ACAG – suggested that DPIE report on the Hunter Valley Flood Mitigation Scheme twice a year
