### Set aside area management obligations

The set aside area is located on the following land.

Clearing is not permitted in the set aside area except for:

- i. clearing that is required to improve vegetation condition and
- ii. allowable activities as set out in Schedule 5A Part 4 of the *Local Land Services Act 2013*.

Native vegetation must be established and maintained at 80 stems/ha for over-storey species and 120 stems/ha for mid-storey species;</li> <li>b. The set aside area must be revegetated with native vegetation including but not limited to: <ol style="list-style-type: none"> <li>i.
