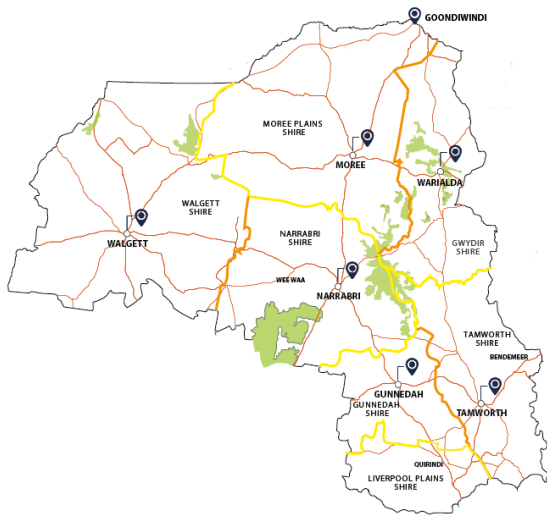
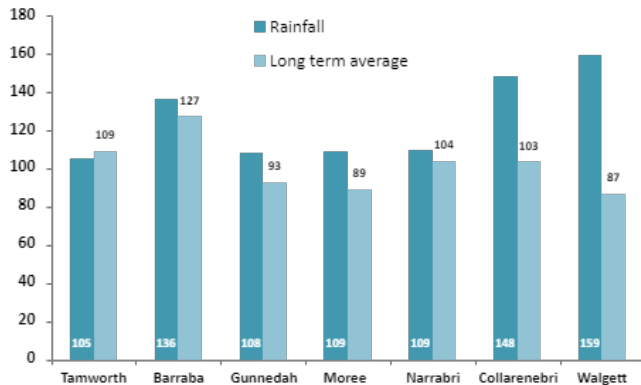


North West Local Land Services Travelling Stock Reserves

Monitoring

Condition

96 condition assessments, including 26 Management Agreement Permits areas, were completed for the quarter with 99% in the 'Excellent' condition category. All reserves were assessed as suitable for grazing.

Quarterly pasture growth rates **Very High**

Growth rates mostly above 1,000+kgDM/ha for the quarter across the region.

*Pasture biomass **High & Stable**

Remains variable throughout the region, ranging from 500 – 3000+kgDM/ha (Aussie Grass).

**North West LLS targets a pasture biomass of 1200kgDM/ha or pasture utilisation levels above 10cm as suitable for grazing.*

Ground cover **High & Stable**

Groundcover levels remain high and above critical thresholds across the region.

Combined Drought Indicator **Stable**

All of the North West Local Land Services region in the 'Non-Drought' category.

Status of Uses

Short term grazing permits

Will only be allowed where enough groundcover and pasture biomass is available as determined by the TSR Ranger.

Roadside grazing permits

North West Local Land Services permits roadside grazing use after the stock owner receives approval from the local Council.

Please note: Roadside Grazing Permits attract a permit fee.

Routine Stock Movements permits (RSMP)

Permits remain in place.

Management Agreement Permits

Remain in place.

Walking Stock permits

Increased to a maximum 1,000 dry cattle or 6,000 dry sheep.
