Applicants please note:

- Under the Local Land Services Act 2013, applicants who accept funding for project activities may be ineligible to use the funded activities or project sites in future proposals for clearing of Native Vegetation.
- Successful on-ground activities will be subject to a 10-year agreement from the completion of on-ground works.
- Funding availability is limited.
- Non-payment of rates and other Local Land Services fees and accounts may result in application ineligibility.
- Landholders who receive incentive funding must agree to have a Cultural Heritage Survey on the project site. This will be organised by Central West Local Land Services staff, at no cost to the landholder. Identified Aboriginal heritage values will be registered on the Aboriginal Heritage Information Management System (AHIMS) and will need to be protected as part of the project.
