

Feral Pig and Pest Program 2024-2025

Progress update | January 2025



The NSW Government's \$13.1 million Feral Pig and Pest Program 2024-2025 reflects the ongoing commitment to reduce feral pig and pest animal populations and the impacts to agriculture and the environment.

Local Land Services has ramped up coordination of control efforts statewide, while local biosecurity officers work with landholders to better equip them to manage pest animals into the future.

Farmers harvesting crops have seen the damage pest animals leave behind, following a period of ideal breeding conditions.

As summer progresses, drier times may see pest animals gathering around water, providing an opportunity for targeted control.

What work is being done across the state:

- continued coordination of broadscale aerial and ground control programs
- targeted engagement to increase landholder participation in control programs
- hosting pest animal management education and training events for landholders
- providing free Vertebrate Pesticide Induction Training (VPIT) courses

- monitoring pest animal impacts within target areas and capturing landholder perceptions of impacts on their property
- collaborating with public land managers for effective control programs across tenures
- fully subsidising 1080 poisoned bait to eligible landholders for feral pig control.

"I could be sitting at the header one day and see 20-30 hectares decimated by pigs."

Grain grower and cattle producer Jack Pearlman, of the Northern Tablelands, knows the losses feral pigs can cause to crops during harvest.

Working with his neighbours, he has controlled more than 1,300 feral pigs and built his capacity to continue into the future.

"It's labour-intensive work but to learn different control methods and tools from Local Land Services and having their support to continually get on top of feral pig numbers over a longer period, showed me the impact you can achieve through longer control programs."

Key results from July to December 2024







Engagement

- 14,716 consultations with land managers for pest animal management
- 36 awareness events across the state with 649 participants
- 140 landholders surveyed as part of impacts monitoring
- 725 participants at free Vertebrate Pesticide Induction Training (VPIT) courses held online and 53 participants at 5 courses in person



Ground control

- 3,805 feral pigs controlled through coordinated ground control programs
- 1,381 properties participating
- 2,599,488 hectares protected through ground control
- 61,528 kg free bait issued to landholders on 647 instances
- 78,960 kg free feed grain supplied to 407 landholders for trapping programs



Aerial control

- 29,253 feral pigs and 5,918 deer controlled during 14 aerial control programs
- · 1,295 properties participating
- 1,434,659 hectares protected through aerial control

These statistics for July to December 2024 relate to activities funded by the 2024-25 Feral Pig and Pest Program. Local Land Services has further pest management activities not reported as part of this funding.
