TERMS AND CONDITIONS

1. In order to amalgamate a number of holdings under a single PIC the land must fit the definition of working as a single property and is proximate. Working as a single property means regular movements of grazing stock occur between the holding such as the holdings a effectively paddocks of one larger property.
2. All land covered by the PIC will share the same disease and residue status.
 - a. Any PIC status recorded on the NLIS database will apply to ALL land registered under that PIC.
 - b. Any disease or residue traceback on an animal bearing that PIC will implicate all Holdings and all stock on those Holdings registered under the PIC of the animal involved.
3. If the original PIC of the Holding/s you wish to change is no longer to be used it will be made INACTIVE on all LLS systems and on the NLIS database and therefore not able to be used on any stock.
4. It is the responsibility of the landholder to carry out any stock and/or tag transfers from a PIC being made inactive to the appropriate active PIC.
5. The National Vendor Declarations (NVD) relating to any PIC/s made inactive can no longer be used to transport stock. Only NVDs linked to the new PIC can be used.
6. When applying to make changes to PICs you need to be aware of the risks and be willing to accept the consequences.
 - a. If one Holding has a higher disease or residue rating than other holdings ALL Holdings will be put under the higher status.
 - b. There could be merit in keeping Holdings on separate PICs to ensure not all stock are caught up any restriction that might be applied to Holdings.
 - c. Such considerations need to be made prior to making any PIC changes.
7. If any Property Identification Codes (PICs) listed are EU accredited it is the responsibility of the PIC Manager to notify Australia Government Department of Agriculture of proposed changes prior to requesting PIC amalgamations
8. If the property is leased a copy of the lease agreement or approval in writing from the property owner will accompany this application.
